ACCA Assessments

Applied Knowledge

Students are assessed using computer-based testing with multiple choice questions. Each test typically lasts for 2 hours and they are available on demand to be taken throughout the year.

Applied Skills

Students sitting exams for these levels will undertake computer-based exams that take place in March, June, September, and December at an ACCA venue. The LW exam is available as an on demand CBE.

Strategic Professional

This consists of essential and option modules. These are assessed through paper based exams. Students sitting exams for these levels will undertake written exams that take place in March, June, September, and December at an ACCA venue.

To qualify as an ACCA member you should:

- Complete 13 exams (a maximum of nine are eligible for exemptions)
- Gain 3 years of practical experience (PER)
- Complete the online Ethics and Professional Skills module (EPSM)
